**ARTICLES OF ORGANIZATION  
OF  
STAR SPORTS MEDICINE, PLLC**

The undersigned, Juliet DeCampos, M.D. a natural person competent to contract and member of STAR SPORTS MEDICINE, PLLC, hereby presents these Articles of Organization for the formation of a professional limited liability company under the provisions of Chapters 621 and 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the professional limited liability company is STAR SPORTS MEDICINE, PLLC. This professional limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The initial mailing address of the Company is 3400 Oakmont Drive, Pensacola, Florida 32503, and the initial street address of the principal office of the Company is 3400 Bayou Boulevard, Suite #107, Pensacola, Florida 32503. The Company's mailing address and principal office may hereafter be at such other place or places as its member or members from time to time may determine.

**ARTICLE III - PURPOSES AND POWERS**

This Company is organized for the purpose of providing professional medical services and for any other legal and lawful purpose for which a professional limited liability company may be organized and shall have all powers and rights which a professional limited liability company may exercise under the Professional Service Corporation and Limited Liability Company Act and the Revised Limited Liability Company Act as such Acts presently exist or as they may hereafter be amended.
