ARTICLES OF ORGANIZATION
of
AGUA VIVA RESTAURANT GROUP, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be Agua Viva Restaurant Group, LLC (the "*Company*"). The mailing and street address of the principal office of the Company shall be 25 Cuna Street, St. Augustine, Florida 32084.

ARTICLE II

PURPOSES AND POWERS

MANAGER

The Company shall be managed by one or more managers and is, therefore, a manager-managed limited liability company. The managers shall be elected in the manner set forth in the Operating Agreement of the Company. 
