ARTICLES OF ORGANIZATION

OF

WATER TREATMENT OF THE PALM BEACHES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - Name

The name of the Limited Liability Company is WATER TREATMENT OF THE PALM BEACHES, LLC (the "Company").

ARTICLE III - Duration

ARTICLE VII - Admission of New Members
