**AMENDED AND RESTATED ARTICLES OF ORGANIZATION  
OF  
LIVING WITH IVEY LLC**

Pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, the undersigned manager and authorized representative of the Member, hereby adopts the following amended and restated articles of organization (the "Amended and Restated Articles of Organization") of **LIVING WITH IVEY LLC**, a limited liability company duly organized and existing under the laws of the State of Florida, as filed on September 9, 2020 and amended on August 1, 2023, and assigned document number 1.20000281206, and confirms that these Amended and Restated Articles of Organization hereby amend and restate the provisions of the Company's original Articles of Organization in their entirety:

**ARTICLE I. NAME**

The name of the limited liability company is **LIVING WITH IVEY LLC** (the "Company").

**ARTICLE II. ADDRESS**
