

WITHDRAWAL FROM AND ASSIGNMENT OF INTEREST IN LIMITED LIABILITY COMPANY

[Withdrawal by Sejal Desai as Member of The Womb LLC and Assignment to Richard M. Rivera of 50% Interest]

This assignment is made between Sejal Desai ("Transferor") and Richard M. Rivera ("Transferee").

The parties to this instrument hereby do and agree as follows:

- 1. Recitals. Transferor and Transferee are the only members of The Womb LLC, a Florida limited liability company (the "LLC"), each owning a 50% interest therein. It is intended by this instrument to effect a withdrawal of Transferor as a member of the LLC and an assignment from Transferor to Transferee of all of Transferor's interest in the LLC, so that Transferee will be the sole remaining member and Transferor will have no further ownership interest in the LLC.
- 2. <u>Withdrawal, Transfer and Acceptance</u>. Transferor hereby withdraws as a member of the LLC and transfers and assigns to Transferee all of Transferor's 50% ownership interest in the LLC (the "Transferred Interest"), free and clear of any encumbrances. Transferee, as the sole remaining member of the LLC hereby consents to Transferor's withdrawal as a member and accepts the transfer of said membership interest, and agrees to hold Transferor harmless from any claims which may be made against her as a member or manager of the LLC, arising before or after the date of this withdrawal and assignment.
- 3. <u>Risignation of Transferor</u>. Transferor hereby resigns as a manager and all other positions, if any, held by her as an officer or otherwise in the LLC. Transferee agrees to promptly take or cause the LLC to take such actions as may be required to amend the current annual report of the LLC remove Transferor's name as an officer of the LLC or to otherwise reflect any association of Transferor with the LLC.
- 4. <u>Power of Attorney to Transfer</u>. Transferor hereby irrevocably constitutes and appoints any officer of the LLC as her attorney-in-fact to transfer the Transferred Interest on the books of the LLC, with full power of substitution in the premises.
- 5. <u>Counterparts</u>. This instrument may be executed in one or more counterparts, each of which shall be deemed an original, but which together shall constitute the same instrument; and signatures delivered by email delivery of a ".pdf" format data file shall be given the same legal force and effect as original signatures.
