The undersigned hereby submits these Articles of Organization (these "*Articles of Organization*") for purposes of forming MHMR Consulting of Florida, LLC, a Florida limited liability company, under the Florida Revised Limited Liability Company Act, Chapter 605, *Fla. Stat.*

**ARTICLE I – Name:**


