**ARTICLES OF ORGANIZATION  
OF

The undersigned, Robert A. McIntosh, a natural person competent to contract and an authorized representative of COMAC GCC, LLC, hereby presents these Articles of Organization as the Articles of Organization of COMAC GCC, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I – NAME**

The name of the limited liability company is COMAC GCC, LLC. This limited liability company is referred to in these Articles of Organization as the “Company.”

**ARTICLE II – PRINCIPAL OFFICE ADDRESS**
