**ARTICLES OF ORGANIZATION
OF

The undersigned authorized representative of a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I

Name, Mailing Address and Purpose of Organization

The name of this limited liability company is Chill-Meda, LLC (the "Company"). The Company's principal address and mailing address is 9702 Harney Road, Thonotosassa, Florida 33592. 


