ARTICLE 1 - NAME

ARTICLE 4 - DURATION

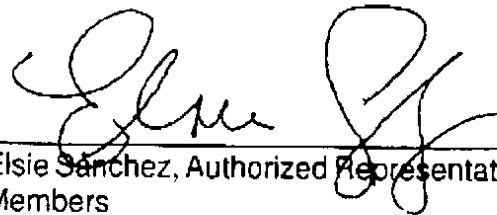

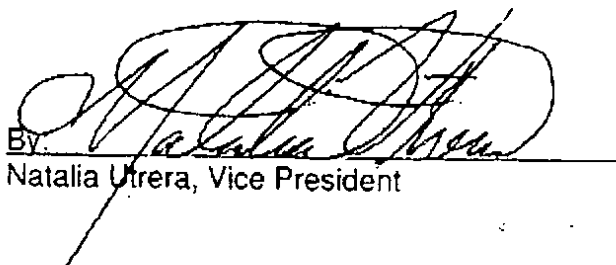
