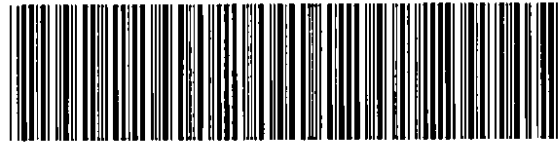




ARTICLE VII
