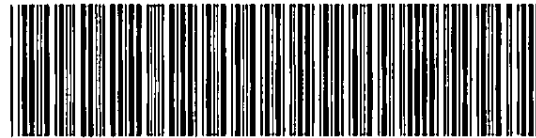

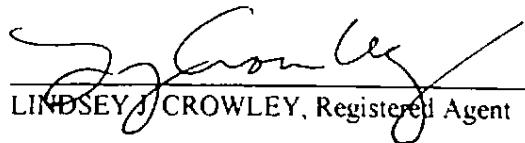
ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND ADDRESS

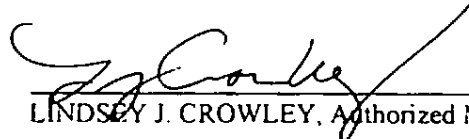
ARTICLE VII - CONTINUATION OF BUSINESS

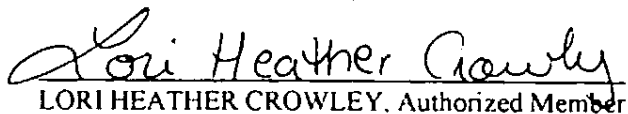
