**ARTICLES OF ORGANIZATION
OF

The undersigned, Donald J. Theriot, a natural person competent to contract and an authorized representative of Kitchen Equipment & Supply Company of Central Florida, LLC, hereby presents these Articles of Organization as the Articles of Organization of Kitchen Equipment & Supply Company of Central Florida, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Kitchen Equipment & Supply Company of Central Florida, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The initial mailing address and principal address of the Company is 1600 W. Main Street, Pensacola, Florida 32502. The Company's mailing address and principal office may hereafter be at such other place or places as its members from time to time may determine.

ARTICLE III - PURPOSE AND POWERS

The Company is organized for any legal and lawful purpose for which a limited liability company may be organized and shall have all powers and rights which a limited liability company may exercise pursuant to Chapter 605, *Florida Statutes*.

ARTICLE IV - COMMENCEMENT AND TERM OF EXISTENCE

The date for commencement of the Company's existence shall be September 21, 2020. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.


ARTICLE V - REGISTERED OFFICE AND AGENT


