**ARTICLES OF ORGANIZATION
OF

The undersigned authorized representative of a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I

Name, Mailing Address and Purpose of Organization

The name of this limited liability company is Salty Dog Kayak Rentals, LLC (the "Company"). The Company's principal address and mailing address is 9940 Green Ivy Drive, Trinity, Florida 34655. 
