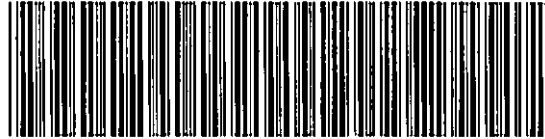



AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF

BLUE CEDAR INVESTMENTS, LLC

The undersigned hereby submits these Amended and Restated Articles of Organization (these "**Articles of Organization**") for **Blue Cedar Investments, LLC**, a Florida limited liability company, under the Florida Revised Limited Liability Company Act, Chapter 605, *Fla. Stat.*

These Articles of Organization amend and restate in the entirety any prior articles of organization previously filed on behalf of the Company with the Florida Secretary of State.

ARTICLE I. Name:

The name of the limited liability company is Blue Cedar Investments, LLC, a Florida limited liability company (the "**Company**").

ARTICLE II. Address:

The mailing and street address of the Company is 210 Hangar Road, Kissimmee, Florida 34741.

ARTICLE III. Duration:

ARTICLE VII. Registered Agent and Office:


