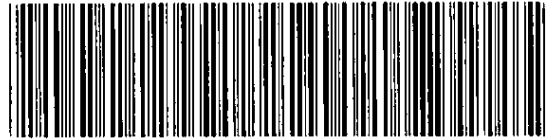

HEREBY CERTIFIES:


FIRST: The name of the limited liability company is **IC REAL ESTATE INVESTMENTS LLC**.
