The undersigned, Travis Brown, a natural person competent to contract and an authorized representative of McLane Family Property, LLC, hereby presents these Articles of Organization as the Articles of Organization of McLane Family Property, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is McLane Family Property, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

The initial registered agent of the Company is Corporation Service Company, and the initial address for that registered agent is 1201 Hays Street, Tallahassee, FL 32301.

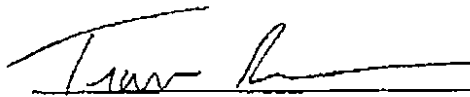
**ARTICLE VI - MANAGEMENT**
