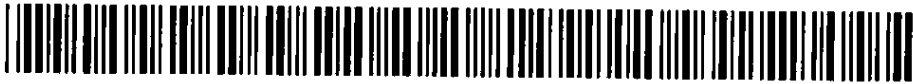

The name of the limited liability company is OnPoint Finance, LLC

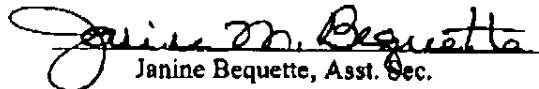
ARTICLE II. ADDRESS
