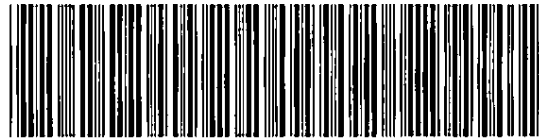


ARTICLE IX - PURPOSE
