**ARTICLES OF ORGANIZATION**  
**of**  
**4145 GRANDCHAMP CIRCLE, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I**

**NAME**

The name of the limited liability company shall be 4145 Grandchamp Circle, LLC (the "*Company*"). The mailing and street address of the principal office of the Company shall be 3308 Summerfield Cove, Palm Harbor, Florida 34683.

**ARTICLE II**

**PURPOSES AND POWERS**
