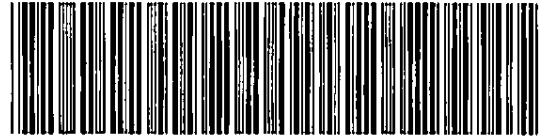



The initial registered office of the Company is 1621 N. Mills Avenue, Orlando, Florida 32803. The initial registered agent at that address is Susan L. Curry.


ARTICLE IV – MANAGEMENT


