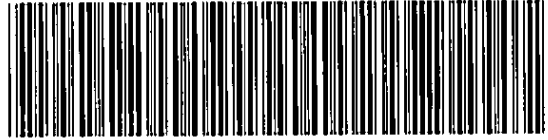


**ARTICLE IV

These Articles of Organization shall be effective upon filing.


