**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
JACKS CREEK PROPERTIES, LLC**

Pursuant to the provisions of Section 605.0202, Florida Statutes, JACKS CREEK PROPERTIES, LLC, a Florida limited liability company (the "Company"), hereby adopts the following amendment to its Articles of Organization:


1. The name of the Company is JACKS CREEK PROPERTIES, LLC.
2. The Articles of Organization of the Company were filed on September 23, 2020 and assigned document number L20000300124.
3. Article IV of the Articles of Organization is hereby amended in its entirety and replaced with the following:

"ARTICLE IV – MANAGEMENT OF THE COMPANY"

4. The sole member of the Company remains James M. Sims.
