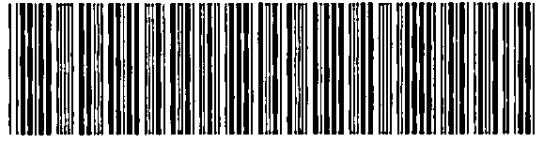

"The Florida Revised Limited Liability Company Act" as amended, the below named entity adopts these Articles of Organization as of the date and time when these Articles of Organization are filed, as evidenced by the Department of State's date and time endorsement on this original document, in accordance with the following:

**ARTICLE I – NAME**

The name of the Limited Liability Company is 5501 S. Atlantic Unit 603, LLC.
