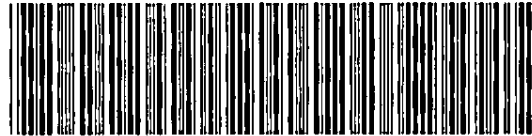

**ARTICLES OF ORGANIZATION
5501 S. ATLANTIC UNIT 603, LLC.
FLORIDA LIMITED LIABILITY COMPANY**

Pursuant to Florida Statutes Chapter 605 et seq. "The Florida Revised Limited Liability Company Act" as amended, the below named entity adopts these Articles of Organization as of the date and time when these Articles of Organization are filed, as evidenced by the Department of State's date and time endorsement on this original document, in accordance with the following:

ARTICLE I – NAME

The name of the Limited Liability Company is 5501 S. Atlantic Unit 603, LLC.

ARTICLE II – ADDRESS

The mailing address and street address of the principal office of the Limited Liability Company is 1760 Legion Drive, Winter Park, Florida 32789.

ARTICLE III – REGISTERED AGENT

ARTICLE VI – ADMISSION OF ADDITIONAL MEMBERS

Except as set forth in the regulations, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his interest only as set forth in the regulations of the company.

ARTICLE VII – MEMBER'S RIGHT TO CONTINUE BUSINESS

The unanimous approval of the remaining members is required to continue the business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event that terminates the continued membership of a member in this limited liability company.

ARTICLE VIII – CAPITAL CONTRIBUTIONS


The members of the company shall contribute to the capital of the company by way of cash or property.

ARTICLE IX – ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the company only on the unanimous consent of all members, or as provided in the regulations.
