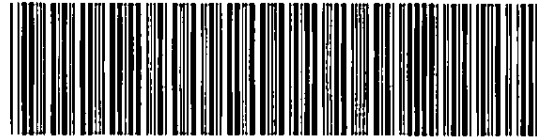

**ARTICLE I
NAME**

The name of the Company shall be: **MAXFOCUS MUSIC LLC.**




