

ARTICLES OF ORGANIZATION

OF

WERNER MANAGEMENT, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act (Chapter 605 of the Florida Statutes), hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I NAME

The name of this limited liability company is Werner Management, LLC (the "Company").

ARTICLE II ADDRESS

The Company's mailing address shall initially be 1428 Lakeview Road, Lake Wales, F1. 33853, and the street address of the Company's principal office shall initially be the same.

ARTICLE III DURATION

Any provision of the operating agreement adopted by the members may be repealed or altered and new provisions may be adopted by the members, in accordance with the operating agreement or the Florida Revised Limited Liability Company Act, or any successor thereto.

ARTICLE VIII AMENDMENT OF ARTICLES

The Company reserves the right to amend these articles of organization, from time to time, in any and as many respects as may be desired, in accordance with the manner and procedures now or hereafter provided by the Florida Revised Limited Liability Company Act, or any successor thereto.
