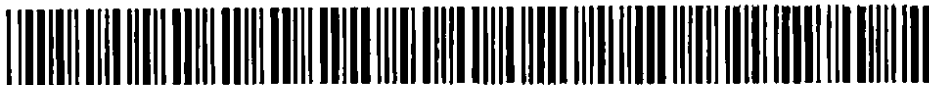


**ARTICLE VII
