ARTICLES OF ORGANIZATION OF WALRUS HOLDINGS, LLC

The undersigned, pursuant to the provisions of Chapter 605 of the Florida Statutes, for the purpose in the purpose of forming a limited liability company under the laws of the State of Florida does set forth the following:

ARTICLE I - Name

The name of the limited liability company is: **WALRUS HOLDINGS**, **LLC**, hereinafter referred to as the "Limited Liability Company."
