**ARTICLE V (REGISTERED AGENT)**

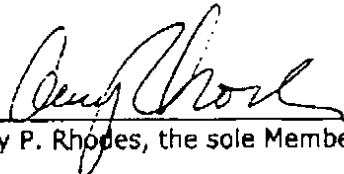

The Company is to be a member-managed company.

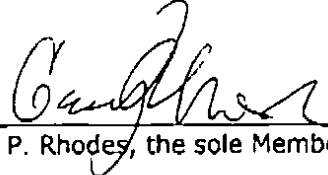

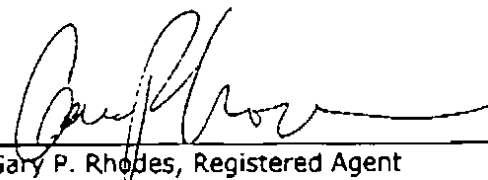
