### ARTICLES OF ORGANIZATION OF MB Commerce, LLC

To enter into and make all necessary contracts for its business with any person, entity, partnership, association, domestic or foreign, or of any domestic or foreign state, government, or government authority, or of any political or administrative subdivision, or department, and to perform and carry out, assign, cancel or rescind any of such contracts.
- 5. ### ARTICLE V MEMBERSHIP RESTRICTIONS
