**ARTICLES OF ORGANIZATION
OF

The undersigned, E. JEAN DABEZIES JR., a natural person competent to contract and the sole member of MALLORY GENERAL, LLC, hereby presents these Articles of Organization as the Articles of Organization of MALLORY GENERAL, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is MALLORY GENERAL, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

ARTICLE III - PURPOSES AND POWERS
