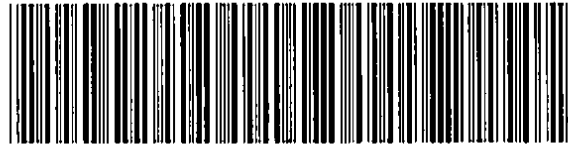

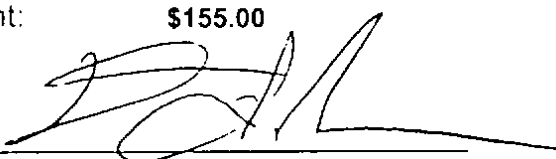

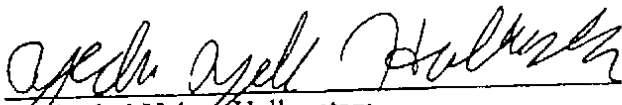

ARTICLE I
CORPORATE NAME

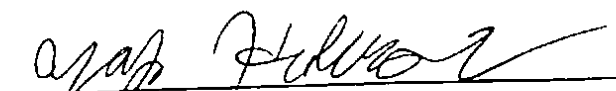
