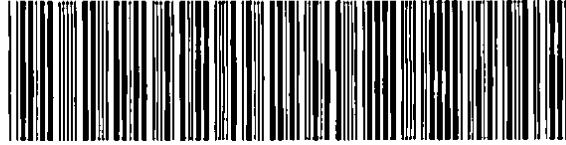

**ARTICLE III: REGISTERED AGENT**






