**ARTICLES OF ORGANIZATION
OF

The undersigned authorized representative of a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby submit the following Articles of Organization:

ARTICLE I

Name

The name of the limited liability company shall be OLYMPUS RECOVERY, LLC.

ARTICLE II


