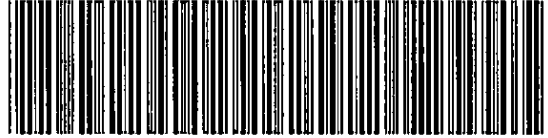

**ARTICLE I - NAME**

The name of this limited liability company is Let's Go Pallets, LLC (the "Company").

This Company shall exist for a period of ninety-nine years from the filing date of these Articles of Organization. Dissolution shall be as set forth in the Operating Agreement.

#### **ARTICLE VII - INDEMNIFICATION**

The Company shall indemnify any officer, member, or manager, or any former officer, member, or manager, to the fullest extent permitted by law and according to the Operating Agreement.

#### **ARTICLE VIII - AMENDMENT**

The members of the Company reserve the right to amend or repeal any provisions contained in these Articles of Organization, or any amendment thereto, and any right conferred upon the manager is subject to this reservation.


## ARTICLE IX - PURPOSE


