ARTICLES OF ORGANIZATION 1000 MIRADOR, LLC

The undersigned, for the purpose of forming a limited liability company and as the Florida Limited Liability Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be 1000 MIRADOR, LLC, . ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 17071 W Dixie Hwy Suite 120, North Miami Beach. Florida, 33160 and the mailing address shall be the same.

The Company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or manager, or upon the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there are at least one remaining member.

ARTICLE 9 - MANAGEMENT

The Company shall be managed by a manager(s) in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulations and management of the affairs of the Company not inconsistent with law of these articles of Organization.
