## ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF CGPI, LLC

All powers of the limited liability company shall be exercised by or under the authority of, and the business and affairs of the limited liability company shall be managed by or under the direction of, the managers of the limited liability company. The Board of Managers of this limited liability company shall consist of a number of persons elected in the manner prescribed by the members of the limited liability company. Each manager shall serve a term as set forth in the Company's Operating Agreement.
