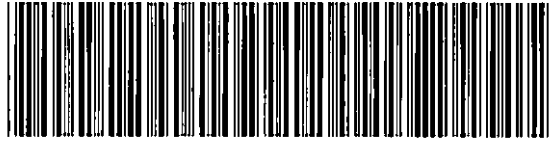

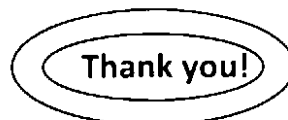

**ARTICLES OF CONVERSION

Pursuant to the provisions of the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, these Articles of Conversion are submitted for the purpose of converting (the "Conversion") **SUMMIT CONTRACTING GROUP SE, INC.**, a Florida corporation, into **SUMMIT CONTRACTING GROUP SE, LLC**, a Florida limited liability company.

1. The name of the converting entity is **SUMMIT CONTRACTING GROUP SE, INC.**, a corporation duly incorporated under the laws of the State of Florida on February 4, 2019.

2. The Plan of Conversion governing the Conversion has been approved in accordance with all applicable statutes.

3. The name of the converted entity is **SUMMIT CONTRACTING GROUP SE, LLC**, and the converted entity is a Florida limited liability company. The articles of organization of **SUMMIT CONTRACTING GROUP SE, LLC** are attached hereto as Exhibit A.

4. The Conversion shall be effective upon the date of filing of these Articles of Conversion with the Department of State of the State of Florida.

5. If the Conversion shall give rise to appraisal rights, the converted entity has agreed to pay to the members of the limited liability company with appraisal rights the amount to which such members are entitled under Section 605.1006 and 605.1061 – 605.1072, Florida Statutes.

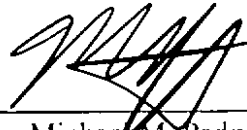

**ARTICLES OF ORGANIZATION
OF
SUMMIT CONTRACTING GROUP SE, LLC**

These Articles of Organization are submitted for the purpose of forming a limited liability company pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, as the same may from time to time be amended, superseded or replaced (the "Act").

ARTICLE I - NAME

The name of this limited liability company (the "Company") is **SUMMIT CONTRACTING GROUP SE, LLC**.

ARTICLE II - ADDRESS
