
MANAGEMENT

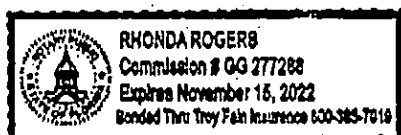

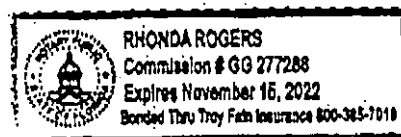


