The name of the limited liability company is: Waterside Acquisitions, I.L.C.

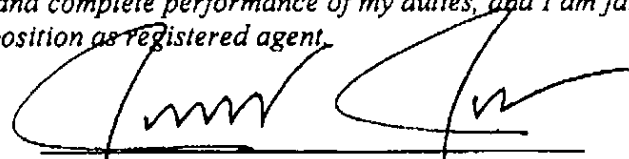
**ARTICLE II. ADDRESS**

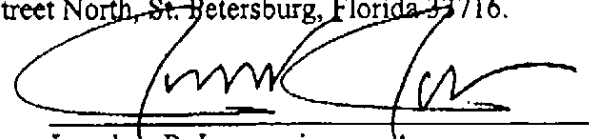
