ARTICLES OF ORGANIZATION OF ROBERT FLEMING, III, PLLC

The undersigned, Robert Fleming, III, a natural person licensed to practice law in Florida and the sole member of this professional limited liability company, hereby presents these Articles of Organization for the formation of a professional limited liability company under the provisions of Chapter 621, Florida Statutes.

ARTICLE I - Name

The name of the professional limited liability company (hereinafter the "Professional Limited Liability Company") is: Robert Fleming, III, PLLC.

ARTICLE II - Address

The mailing address and the street address of the principal office of the Professional Limited Liability Company are: 2714 West 15th Street, Panama City, Florida 32401.

ARTICLE III - Purpose and Powers

The Professional Limited Liability Company is organized for the purpose of providing professional legal services for any legal and lawful purpose for which a professional limited liability company may be organized and may exercise all powers and rights which a professional limited liability company may exercise under the Professional Service Corporation and Limited Liability Company Act.

ARTICLE IV - Members

Individual members must be licensed to practice law in the State of Florida. The shareholders of any member that is a professional service corporation and the members of any member that is a professional limited liability company must each be licensed to practice law in the State of Florida. Contributions required of new members shall be determined as of the time of admission to the Professional Limited Liability Company in accordance with its Operating Agreement.

A member's interest in the Professional Limited Liability Company may not be sold or otherwise transferred except to a person licensed to practice law in the State of Florida, in accordance with the Operating Agreement of the Professional Limited Liability Company.

ARTICLE V - Duration

The period of duration of the Professional Limited Liability Company shall be perpetual.

ARTICLE VI - Management

The Professional Limited Liability Company is to be managed by its sole member. The name and address of the member are: Robert Fleming, III, 2714 West 15th Street, Panama City, Florida 32401.

ARTICLE VII - Registered Agent

The name and street address of the initial registered agent of the Professional Limited Liability Company are: Robert Fleming, III, 2714 West 15th Street, Panama City, Florida 32401.

ARTICLE VIII - Time of Formation

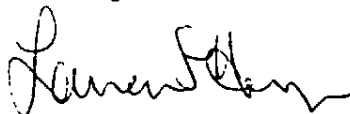

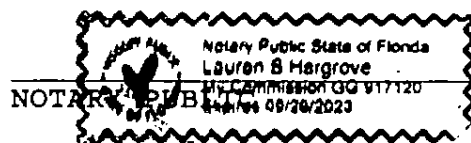
