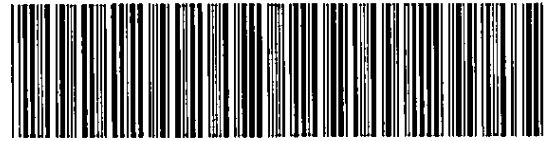

NAME


