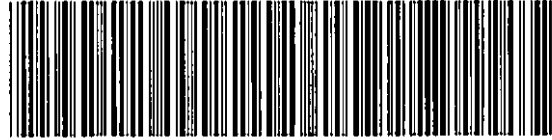



The undersigned, as an officer of MHP FL X GP, LLC, a Florida limited liability company (the "**Company**"), desiring to further amend the Articles of Organization of the Company pursuant to the terms of Chapter 605, Florida Statutes, the Florida Revised Limited Liability Company Act (the "**Act**"), states as follows:

1. The current name of the Company is MHP FL X GP, LLC.

2. The original Articles of Organization were filed with the Florida Department of State on October 30, 2020 under the name MHP FL X SLP, LLC (the "**Initial Articles**"). The Initial Articles were amended by the filing of Articles of Amendment with the Florida Department of State on March 14, 2022 in order to change the name of the Company to MHP FL X GP, LLC and further amended by the filing of Articles of Amendment with the Florida Department of State on March 30, 2022 (as the same may be further amended from time to time, the ("**Articles**").

3. The Articles are amended by deleting Article V in its entirety and replacing with the following:


