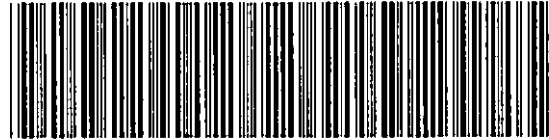

**ARTICLES OF ORGANIZATION
FOR
FLORIDA LIMITED LIABILITY COMPANY**

The undersigned certifies that I have associated myself for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of a limited liability company for profit. I further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company:

ARTICLE I – NAME OF THE LIMITED LIABILITY COMPANY

The name of the limited liability company shall be:

ARTICLE II – PRINCIPAL PLACE OF BUSINESS

This limited liability company shall have the power and authority to establish branch offices at any other place or places as the President may designate.

ARTICLE III – PURPOSES AND POWERS

In addition to the powers authorized by the laws of the State of Florida for limited liability companies, the general nature of the business or businesses to be transacted, and which the limited liability company is authorized to transact, shall be as follows:

1. Provide music production products and services. To be an organization that displays creativity through various forms of media such as music, art, film and photography.
2. To engage in any activity or business authorized under the Florida Statutes and carry on any and all incidental business without limitation.
3. To enter into and make all necessary contracts for its business with any person, entity, partnership, association, corporation, domestic or foreign, or of any domestic or foreign state, government, or governmental authority, or of any political or administrative

subdivision, or department, and to perform and carry out, assign, cancel, or rescind any of such contracts.

4. To exercise all or any of the limited liability company powers, and to carry out all or any of the purposes, as listed in these Articles and otherwise granted or permitted by law.

5. Nothing contained in these Articles shall be deemed or construed as authorizing or permitting, or purporting to authorize or permit the limited liability company to carry on any business, exercise any power, or do any act which a limited liability company may not, under Florida laws, lawfully carry on, exercise, or do.

ARTICLE IV – EXERCISE OF POWERS

All limited liability company powers as well as its business and affairs, shall be exercised and managed under the authority and direction of the President of the limited liability company. This Article may be amended from time to time in the regulations of the limited liability company by the President of the limited liability company.

ARTICLE V – MANAGEMENT RESPONSIBILITIES

This limited liability company shall initially have a Manager and when necessary, in the future, a Board of Directors appointed by the President consisting of one (1) person who will serve as the President and Manager and 2 (two) or more persons who will serve as Directors/Advisors. The number of Directors/Advisors may increase from time to time and may be appointed by the President. ARTICLE VIII – BY-LAWS

ARTICLE IX – AMENDMENT TO ARTICLES

These articles of organization may be amended in any manner permitted by law by the President of the company.
