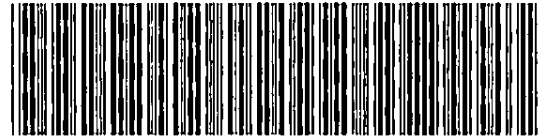

Articles of Organization of Limited Liability Company

Tampa Youth Missions

Article I: Name

The name of the limited liability company is Tampa Youth Missions, LLC.

Article II: Purpose

Tampa Youth Missions, LLC is an integrated auxiliary of Northwest Tampa Church of Christ and is an IRS Section 501(c)(3) charitable organization and a public charity under IRS Section 509(a)(1) and IRS Section 170(b)(1)(A).

The purpose of Tampa Youth Missions, LLC. is to promote and share the gospel of Christ through the teaching of God's word around the world. This includes the teaching of the Bible, providing financial and physical assistance, engaging in the uncompensated building of dwellings, churches and other buildings with the aim to spread the love of God. The LLC's purpose is strictly limited to the above charitable activities.

Tampa Youth Missions, LLC. is to be operated exclusively to further the charitable purposes of Northwest Tampa Church of Christ, Inc.

Furthermore, Tampa Youth Missions, LLC. shall not merge with, become or convert into a for-profit business entity.

Article III: Members

The sole Member of Tampa Youth Missions, LLC is Northwest Tampa Church of Christ, Inc. a 501(c)(3) organization.

Membership interest in Tampa Youth Missions, LLC. may not be transferred, directly or indirectly, to any recipient other than a section 501(c)(3).

Northwest Tampa Church of Christ, Inc. or any successor member will enforce all LLC rights to pursue all legal and equitable remedies and to protect LLC interests.

Article IV: Transfers

Interests in the LLC or its assets may only be transferred to a nonmember other than a 501(c)(3) organization in exchange for fair market value.

Tampa Youth Missions, LLC. shall not distribute any assets to any member who ceases to be a 501(c)(3). In the event that Northwest Tampa Church of Christ, Inc. ceases to be a 501(c)(3), Tampa Youth Missions, LLC. and all assets shall immediately and without delay be transferred to qualified 501(c)(3) organization(s) whose charitable purposes align with those of Northwest Tampa Church of Christ as they exist on the day of Tampa Youth Missions organization. In the event that said transfer cannot be completed prior to the loss of 501(c)(3) status, Tampa Youth Missions shall be dissolved and all assets shall be dealt with in accordance with Article V.

Article V: Dissolution

Upon any further dissolution, all assets of Tampa Youth Missions, LLC will continue to be devoted only to charitable purposes.




