4. Place of Principal Office. The mailing and street address of the Company's principal office is 801 Brickell Avenue, Suite 500, Miami, Florida 33131.

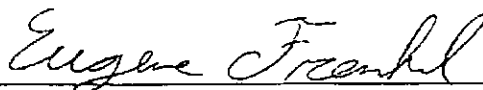
