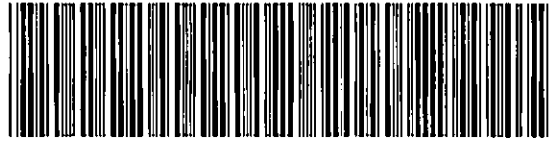

NAME**


