**ARTICLE III – REGISTERED OFFICE AND AGENT**

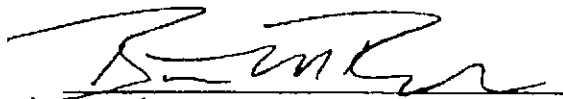

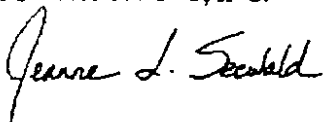
