**ARTICLES OF AMENDMENT  
TO ARTICLES OF ORGANIZATION OF

THE UNDERSIGNED, hereby executes and swears to these Articles of Amendment to Articles of Organization of **RIVETERS TAMPA, LLC**, a Florida limited liability company (the "Company"), pursuant to the Florida Revised Limited Liability Company Act, as amended, Florida Statutes § 605.0202:

1. **Name of Company.** The name of the Company is Riveters Tampa, LLC.
