ARTICLES OF ORGANIZATION

OF

These Articles of Organization are made for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act (Ch. 605, Florida Statutes, 2017).

ARTICLE I

NAME

The name of this limited liability company is STONE KREWE SEAFOOD, LLC (the "Company").

ARTICLE II

DURATION

The Company shall exist for indefinite duration from the date of filing these Articles of Organization with the Department of State until the occurrence of any of any of the events specified in Section 605.0701, Florida Statutes (2017), unless continued by the unanimous consent of all of the remaining members.

The existence of the Company shall commence on the date of filing of these Articles of Organization with the Department of State.

ARTICLE X

POWERS

The Company shall have all powers as are provided in Section 605.0109, Florida Statutes (2017), and such other powers as are set forth in the Operating Agreement of the Company.
